By signing this agreement, I hereby acknowledge that I have received and read a copy of the Offering Statement. I also acknowledge that I have specifically noted the description of the Securities Offered in Section 8 and the Risk Factors in Section 5 of the Offering Statement. I further acknowledge that I have been advised that there can be no assurance that I will receive any dividends or return of capital on these Bonds or be able to redeem these Bonds upon request.

I understand that the Co-operative is in its development phase with no record of operations, that there are substantial risks associated with my investment in the Co-operative, and that once I have provided funds to the Co-operative, I may lose my entire investment. I also understand that there are restrictions upon the transfer of these Bonds and that there is presently no market for the securities being issued and there is no assurance that any such market will develop. I have considered whether or not I should obtain independent advice on the suitability of this investment to my particular financial situation, and I have either obtained such advice or determined that I do not require such advice.
